



# The 2021 Black Prosperity Agenda

Since 2020, the Black Leadership Council (BLC) has mobilized to support and develop a sweeping collection of policies to advance a *Black Prosperity Agenda* through comprehensive reforms to the state's healthcare, economic, housing, and education systems that drive racialized inequities amongst Black and other low-income Californians.

#### **Legislative Priorities and Support Bills**

#### Wealth Building

**SB 471 (Hueso) – The Racial Economic Equity Bond Act of 2021 –** This bill would would appropriate \$3.3 billion to the Governor's Office of Business and Economic Development (Go-Biz) to develop a grant program to address the disproportionate impacts borne from the COVID-19 pandemic and the lack of critical physical and social infrastructure resulting from chronic underinvestment in key segments of our economy.

**SB 655 (Bradford)** – **Insurers diversity** – This bill helps improve diversity in the insurance industry so that those who are making important life-changing policies are more reflective of California's population.

**AB 915 (Chiu) – Small and disadvantaged business enterprises –** This bill would require the development of an "economic equity first" action plan to ensure disadvantaged businesses are benefitting from the state's procurement process.

#### Health Equity

**SB 17 (Pan) – Office of Racial Equity –** Establishes the Office of Racial Equity to coordinate, analyze, develop, evaluate and recommend strategies for advancing racial equity across state government.

**AB 666 (Chiu) – Substance use disorder workforce development –** This bill assesses the state's systems for regulating and supporting the Substance Use Disorder workforce.

**AB 1407 (Burke) – Implicit Bias –** This bill would require implicit bias education and training for registered nurses in California.

## Housing

**AB 946 (Lee) – Home Purchase Assistance Fund –** This bill would repeal California's Mortgage Interest Deduction on second homes and re-allocate \$230 million annually to provide additional funds to homebuyer assistance programs like the CA Housing Finance Agency's MyHome Assistance Program.

**AB 1241 (Jones-Sawyer) – Rental housing unlawful housing practices: applications: criminal records –** This bill would provide the formerly incarcerated an opportunity to receive a thorough and fair vetting when seeking housing by essentially banning the box.

**AB 1466 (McCarty) – Real property: discriminatory restrictions –** This bill would take proactive steps in removing Jim Crow-Era, racist language from housing documents once and for all.

### **Education Equity**

**SB 50 (Limon) – Early learning and care –** This bill expands the range of types of childcare and early learning services that a state preschool contracting agency may provide. It builds toward a more streamlined, integrated, mixed-delivery ECE system, improving education for everyone.

**AB 932 (Levine) – Cradle-to-Career (C2C) Grant Program –** This bill would establish the C2C Grant Program to streamline funding to local governments and organizations to encourage interventions at crucial stages in a child's development and ensure future success. The bill would help reduce child poverty and achievement gaps.
